



For UK: Door to Door Visits to administer Injections

A plan for sending out teams “*armed with Covid vaccines*” was announced in the UK on 25 December 2021. This is the latest attempt to intimidate and coerce a very large part of the population which has freely chosen not to accept the **experimental** injection. The number is put as high as 25 million people. This article will help you (*as a person pro-choice but not pro jabbing*) to handle such a visit in the best way possible.

WHAT'S IN THE LAW?

On the face of it, **Section 45C** of the **Public Health (Control of Disease) Act 1984** allows the ‘appropriate Minister’ (currently this would be Sajid Javid MP) to introduce measures for the purpose of ‘preventing, protecting against, controlling or providing a public health response’ in an epidemic or outbreak. That is the ‘authority’ under which the Government passed the new Regulations.

However, **Section 45E** of the said Public Health (Control of Disease) Act 1984 stipulates that **those ‘measures’ cannot include a requirement for persons to undergo ‘medical treatment’ which is defined to include vaccination. As such, there is no legal requirement to be vaccinated in the UK.** Because of this, various techniques have been tried to coerce people to take the **experimental** injection, supported by aggressive marketing and behavioural psychology.

This is the actual text of Section **45E:**¹ **Medical treatment**

Regulations under section 45B or 45C may not include provision requiring a person to undergo medical treatment.

(1) “**Medical treatment**” includes vaccination and other prophylactic treatment.

DOOR TO DOOR VACCINATIONS

It is important to **record** the interaction if you can do that.

You may wish to welcome the people and ask them all to provide **photo**



identification and **employer details** which you may later need for legal purposes. If they are not prepared to give you this information, you can ask them to leave your property if you wish, and tell them that **not leaving would be trespass and/or harassment**. If, however, you are confident to engage with them, whether you take their name and details or not, then you can ask them some questions:

Ask them the following:

1. What risk is “covid” to me & my age group?
2. How long have any of you been trained to administer an injection?
3. Are the vaccines which you are using actually ‘**safe**’?
4. Are the vaccines which are being promoted really **effective**?
5. Are these vaccines not currently still in the trial stage?
6. Do the vaccines stop “infection” and “transmission”?
7. What is the list of injuries related so far to these jabs?
8. How many have been injured or have died from the jab?
9. What are the ingredients in this jab?
10. Where is the product insert with all the placebo and safety study information?
11. Which level of immunity is stronger and longer lasting, a **natural** immunity or a **vaccine-induced** treatment?

If they do not answer or are unable to answer, then they are not allowing you a fully informed consent/choice and you can make a formal complaint to their head office.

You can ask them to sign any paperwork you may have already prepared showing what compensation the person injecting you would be charged with paying, as they will become individually ‘**privately accountable and personally liable**’ [this being a significant sum] should you suffer any harm or injury. Ask them to sign it first, this being a condition of you accepting the **risk** of taking the injection.

Provided below is data from the **Yellow Card** reporting system (**MHRA**) for the UK, showing deaths and injuries reported so far, also keeping in mind this is only a fraction of the true numbers, due to under reporting.

This table shows the days between a Covid-19 injection being administered and a death being reported to VAERS. Some **40%** of all US reported deaths from the Covid-19 injections occurred **within 5 days** of a Covid injection, **25%** within **just one day**.
